

**FEE PAYMENT INFORMATION FOR READERS AND TUTORS**

(Note: Fees are subject to change).

Graduate students who are appointed as Readers or Tutors at least 25% percent time for the quarter are eligible to receive partial fee remission that covers the graduate student health insurance (GSHIP), the Registration Fee, and the Educational Fee. These fee payments are deposited into the student’s account at the end of the quarter. The student is responsible for paying his/her own fees at the beginning of the quarter, and the GSHIP and partial fee remission are issued as a refund\* at the end of the quarter after timesheets are submitted by the department to OGS as proof of eligibility (110 hours worked).

**\*NOTE:** **The refund applies only to those students who paid their own fees.** If a student has a health insurance waiver, no refund is issued because there was no charge. If another fund source paid the fees (for example, financial aid, outside agency, or the student’s department) the money is refunded to the fund source, not to the student. If you are receiving financial aid, you should contact the Financial Aid office to determine how the fee payments affect your financial aid.

Fees are different for IR/PS students and those enrolled in profession programs. Refer to the website of the appropriate program.
